 Federation (GUFs) and trade union organisations in the Global South.






SASK in Figure

Annual budget of 5.5 million Euro

- $_{\odot}$ 81% for international operation
- $_{\odot}$ 8% for communication and advocacy
- $_{\odot}$ 11% for administration
- **SASK structure:** Board members and 14 staffs, including 3 in the Global South

Source of funding

- $_{\odot}$ 78% from ministry of foreign affairs
- $_{\odot}$ 17% from SASK affiliates
- $_{\odot}$ 5% from other sources



SASK's Way of Working


- Projects cooperation with GUFs, national centres, federations, or local unions




SASK's Project Partners

- International Trade Union Congress (ITUC) and its regional organisations with 175 million members in 325 affiliates in 161 countries and territories.
- ILO Actrav and Apheda (Union Aid Abroad) from Australia and GLU-WITS in South Africa
- **Building and Woodworkers' International (BWI)** with 351 trade unions from 127 countries represents 12 million members.
- Education International (EI) with 383 trade unions in more than 178 countries represents 33 million teachers.
- IndustriALL Global Union in 140 countries represents 50 million workers.
- International Transport Workers' Federation (ITF) with nearly 700 trade unions representing 20 million transport workers from 150 countries.
- UNI Global Union represents 20 million members in 150 countries
- **PSI Public Services International** with 700 affiliates represents 30 million workers in 54 countries.
- International Domestic Workers' Federation with 83 affiliates in 65 countries represents 590 000 members.

Indonesia: Contextual Update

- Historical win for labor movement against Omnibus Law on Job Creation
 - The win in constitutional court, normalizing the provision on contractual, outsourcing, annual leave, severance pay.
- 6.5% annual wage increase for all provinces
- The rise of military influence

 Introduction of new military law, allowing them to enter key government position

- The biggest corruption in Indonesia history
 - Corruption in Pertamina (oil & gas), almost reached IDR 1 quadrillion (or US\$ 58.96 billion)
- Exploitation of nickel mining and its impact to indegenous people & environment



Philippines: Contextual Update

- President vs Vice President, feud to determine the future
 - The fight between Presiden Marcos Jr.
 And Vice President Sara Duterte
- Former President, Rodrigo Duterte, captured by ICC for past crimes on war on drugs
- Historical win for Akbayan Party (workers party), winning 3 seats in lower house

Background of the Project

Weak internal capacity of unions

• Trade unions lack awareness and capacities.

Poor working Environment

 Though core ILO Conventions are being ratified in both countries, still the national policies and legislation are not yet enacted to support implementation of the conventions (example: C151, C190).

Low Union Membership

- Efforts to increase union membership in Indonesia and in the Philippines, which are still low.
- Gender awareness and appreciation is a work in progress
 - Though gender awareness and education are continuously promoted among workers organizations, the level of comprehension and understanding of gender are still low especially at the workplace level.

Objective of the Project

• Impact (2030)

 By 2030, public service trade unions in Indonesia and in the Philippines are exercising full political, economic, and social rights.

• Outcome (2026)

 By 2025, public service trade unions are strong and able to successfully protect and advancing trade union rights in Indonesia and in the Philippines.

• Output (2025)

- o By 2025, **capacitated and strong public sector unions** in Indonesia and in the Philippines can act, engage, and take actions.
- By 2025, the legislative, executive & key influencers are supporting & endorsing the proposed measures that promote and advance trade union rights
- By 2025, membership to public services trade unions have significantly increased and consolidated
- By 2025, empowered women leaders have taken key role to advancing trade union rights and promoting violence-free workplaces

Main Achievements of the Project

Indonesia

- Historical win against Omnibus Law (Job Creation & Electricity), part of the alliance.
- Advancing the issue of Just Transition nationally, uniting energy union alliances in the process
- First CBA for SP PLN (biggest electric company) after 10 years of deadlock
- First CBA for SP PDAM (biggest water company)

Philippines

- Ratification of ILO 190, first Asia country to do it
- Passing of Omnibus Guidelines in the Exercise of the Freedom of Association and Civil Liberties
- The draft bill of C151 has been ready to be passed
- Positive progress of Nursing Act and approval of Bill No. 2838 on Barangay Health Workers (Community health workers)
- 40 new CBAs (of 65 CBAs in total)
